**ELIGIBILITY:** Entrants must be male amateur members of a Member Club of the St. Louis District Golf Association and must be age 50 or older on or before June 29, 2010. The entrant must have an up-to-date and current USGA GHIN Handicap Index.

**FORMAT:** A dual team competition (gross and net), which is 18 Holes at stroke play. Each team counts the two best balls (gross), and also counts the two best balls (net), utilizing 80% of handicaps. Golf professionals shall have a separate competition utilizing their individual gross score.

**PRIZES:** Low Net and Low Gross Winners will receive 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Place Gift Certificates.

Lowest Gross Team score Champion and will have custody of the Larry Etzkorn Trophy for one year. Any tie(s) for the Gross Champion Team will be decided by the USGA recommended method of matching score cards.

**REGISTRATION:** All players must be ready to play at their appropriate starting point and published starting time.

**RULES OF GOLF:** Play will be governed by the United States Golf Association Rules of Golf.

**ENTRIES:** Entrants shall apply on the attached form. \$270.00 entry fee per team. Entry Application and fees must reach the Association's Office at the address listed on the entry form by **4:00 p.m., June 17, 2010. No Refunds after the deadline.**

**Entry fee includes Hors D' Oeuvres following play.**

**CADDIES; AUTOMOTIVE TRANSPORTATION:**

A player may provide his own caddie at any time during the Championship, provided the caddie is not participating in the Championship, or a player may carry his own clubs. Players may use automotive transportation. Entry fee includes cart fees during play

**GOLF BALLS; EQUIPMENT:** Only brands of golf balls on the most current USGA Conforming Ball List may be used. The Optional Condition, as set forth in Appendix I of USGA Rules of Golf, which places a limitation on golf balls used during a round (One-Ball Rule), is **NOT** in effect. All clubs utilized during the Championship must be conforming under USGA Rules. (See Appendix II, USGA Rules of Golf.)
