ELIGIBILITY: One entrant must belong to a member club of the St. Louis District Golf Association. A father may play with only one son at a time. Contact us if you have 2 sons that you would like to play with.

FORMAT: Selected drive alternate shot twosome. Each player will hit a tee shot. After selecting the tee shot to be played, the player whose shot was not selected will hit the second shot. Continue this procedure until ball is holed out.

Divisions will be made into age groups based on son's ages; 13 & under, 14-15, 16-17, 18-23, 24-34, 35 & over.

Lowest gross Team for 18 Holes will be Champion. Any tie(s) for the overall champion will be decided immediately by a sudden death hole-by-hole playoff. All other ties within a specific age group, see Appendix I of the USGA Rules of Golf, How to Decide Ties, Paragraph (c).

PRIZES: Overall Gross Winner will receive the Sidney Salomon Sr. perpetual trophy. Some merchandise certificates will be awarded to top finishers at the discretion of the Championship Committee.

REGISTRATION: All players must be ready to play at their appropriate starting point - **1:30pm Shot Gun Start.**

ENTRIES: Entrants shall apply on the attached form. \$175.00 entry fee per team shall be paid by every applicant. Entry Application and fees must reach the Association's Office at the address listed on the entry form by **4:00 p.m., July 29, 2010. No Refunds after the deadline.**

Entry fee includes golf, cart and dinner following play.

GOLF BALLS; EQUIPMENT: Only brands of golf balls on the most current USGA Conforming Ball List may be used. The Optional Condition, as set forth in Appendix I of USGA Rules of Golf, which places a limitation on golf balls used during a round (One-Ball Rule), is **NOT** in effect. All clubs utilized during the Championship must be conforming under USGA Rules. (See Appendix II, USGA Rules of Golf.)

RULES OF GOLF: Play will be governed by the United States Golf Association Rules of Golf.
