91st ANNUAL GREISEDIECK MEN'S CHAMPIONSHIP JULY 15-18, 2010 WESTWOOD COUNTRY CLUB

ELIGIBILITY: Entrant must be a male amateur member of a Member Club of the St. Louis District Golf Association or a special invitee. The entrant must have an up-to-date and current USGA GHIN Handicap Index of not more than 8.0. This entry and Handicap must be certified by an Association or Club authorized to issue a USGA GHIN Handicap. Entries are subject to rejection at any time (including during the Championship) by the Championship Committee. The reason for rejection may include unbecoming conduct. Exempt players need not meet the Handicap Index requirement. Championship Committee reserves the right to issue special exemptions.

The field will be limited to the 132 applicants with the lowest USGA GHIN Handicap Indexes.

ALVIN GREISEDIECK SR. MEMORIAL TROPHY

The "Alvin Griesedieck Sr. Memorial Trophy", a beautiful silver trophy emblematic of the St. Louis District Golf Association, donated by Joseph Griesedieck, will be in competition this year. The winner will have custody for one year and will return the trophy in time for the championship the following year.

PRIZES: Overall Winner: Alvin Griesedieck trophy for period of one year. All Participants will receive a Commemorative Gift. Some merchandise certificates will be awarded to top finishers at the discretion of the Championship Committee.

NO OTHER REMUNERATION: By this application, an entrant certifies that he is not entitled to remuneration of any kind for participation in this Championship other than the aforementioned prizes.

ENTRIES: Entrant shall apply on the attached form. \$110.00 entry fee shall be paid by every applicant. Entry Application and fees must reach the Association's Office at the address listed on the entry form by **4:00 p.m., July 1, 2010. No Refunds after the deadline.**

REGISTRATION: All players must be ready to play at appropriate starting point and published starting time.

PRACTICE PRIVILEGES: Practice privileges at Westwood Country Club are extended by appointment only by calling the golf shop at 314-432-2312.

FOOTWEAR: Westwood Country Club is a spikeless facility. Shoes with traditionally designed spikes, comprised either partially or entirely of metal, are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

CADDIES;AUTOMOTIVE TRANSPORTATION:

Each player may walk or ride on a cart during the practice round and the 36-hole qualifying. A caddie may be used at anytime during the Championship, provided the caddie is not a participant in the Championship. **During Match Play** a caddie may drive a cart to transport the player's clubs. The player may not use the cart for transportation. The player or competitor may sit or lean on the cart when it is not moving. **Penalty for breach of this rule: Match Play - Loss of hole.** The Optional Condition, set forth in Appendix 1 of the USGA Rules of Golf, shall be in effect.

TIME OF STARTING: The Optional Condition for Time of Starting, as set forth in Appendix 1 of the USGA Rules of Golf, shall be in effect. (See also Note under Rule 6-3).

CONDITIONS, SCHEDULES: The Championship Committee reserves the right to alter any of the conditions and schedules herein. The decision of the Championship Committee in any matter shall be final.

COMMUNICATIONS DEVICES: No communications devices of any kind shall be permitted on the course during the tournament.

PERSONAL APPEARANCE: During all phases of the Championship, Competitors must be neat in appearance with respect to clothing and personal grooming. The Championship Committee shall decide whether this requirement has been met and has authority to withdraw the entry of a Competitor who does not comply. The wearing of Bermuda length shorts is permitted.

GOLF BALLS; EQUIPMENT: Only brands of golf balls on the most current USGA Conforming Ball List may be used.

The Optional Condition set forth in Appendix 1 of the USGA Rules of Golf, which places a limitation on golf balls used during a round (One-Ball Rule), shall be in effect.

All Clubs utilized during the Championship must be conforming under USGA Rules. (See Appendix II, USGA Rules of Golf)

NOTICE CONCERNING AMATEUR STATUS: Participation in this event is conditioned on Amateur Status. The USGA Rules of Amateur Status shall apply. The Championship Committee reserves the right to disqualify any participant for not having Amateur Status. Disqualifying events include (i) competing for cash prizes in any amount and (ii) competing for merchandise prizes exceeding \$750 in retail value.
