ELIGIBILITY: 2-Man Team Entrants must be male amateur members of a Member Club of the St. Louis District Golf Assoc.

FORMAT: 1st Round – Four-Ball Stroke Play (Best Ball), See Rule 31 of the USGA Rules of Golf. 2nd Round – Foursomes Stroke Play (Alternate Shot), see Rule 29 of the USGA Rules of Golf.

Lowest gross 2- Man Team score for 36 Holes will be Champion. Any tie(s) for the overall champion will be decided immediately by a sudden death hole-by-hole playoff in the Four-Ball Stroke Play format. For all other ties within a specific division, see Appendix I of the USGA Rules of Golf, How to Decide Ties, Paragraph (c).

PRIZES: 1st Prize – Trophy and \$300/Team in Gift Certificates. 2nd Prize - \$200/Team in Gift Certificates. 3rd Prize - \$100/Team in Gift Certificates.

There will be Net and Gross Divisions.

RULES OF GOLF: Play will be governed by the United States Golf Association Rules of Golf.

REGISTRATION: All players must be ready to play at their appropriate starting point and published starting time

ENTRIES: Entrants shall apply on the attached form. \$250.00 entry fee per team shall be paid by every applicant. Entry Application and fees must reach the Association’s Office at the address listed on the entry form by **4:00 p.m., September 2, 2010. No Refunds after the deadline.**

Entry fee includes cart fees and Hors D’Oeuvres on the 1st day of the Tournament

CADDIES; AUTOMOTIVE TRANSPORTATION: A player may provide his own caddie at any time during the Championship, provided the caddie is not participating in the Championship, or a player may carry his own clubs. Players may use automotive transportation. Entry fee includes cart fees during play.

GOLF BALLS; EQUIPMENT: Only brands of golf balls on the most current USGA Conforming Ball List may be used. The Optional Condition, as set forth in Appendix I of USGA Rules of Golf, which places a limitation on golf balls used during a round (One-Ball Rule), is **NOT** in effect. All clubs utilized during the Championship must be conforming under USGA Rules. (See Appendix II, USGA Rules of Golf.)
