#### **ELIGIBILITY:** Entrant

must be a male amateur member of a Member Club of the St. Louis District Golf Association. The entrant must have an up-to-date and current USGA GHIN Handicap Index. This entry and Handicap must be certified by an Association or Club authorized to issue a USGA GHIN Handicap. Entries are subject to rejection at any time (including during the Championship) by the Championship Committee. The reason for rejection may include unbecoming conduct. Entrant must have reached their 25th birthday by May 14, 2017.

The field will be limited to the first 90 applications received. Subsequent applicants will go on wait list.

FORMAT: 18 holes at stroke play

There will be Prizes for Gross & Net Divisions

The lowest score for 18 holes will be the Champion. Any tie(s) for the overall Champion will be decided immediately by a sudden death hole-by-hole play-off.

**PRIZES:** Overall Winner: Overall winner will receive the Bob Cochran perpetual trophy for a period of one year. Some merchandise certificates will be awarded to top finishers at the discretion of the Championship Committee.

## QUALIFIER FOR JIM JACKSON TOURNAMENT-

Top 5 Gross Finishers become eligible for the Jim Jackson Invitational at Algonquin GC-Oct. 20-21, 2018.

ENTRIES: Entrant shall apply either online at <u>STLDGA.com</u> or on the attached form. \$120.00 entry fee shall be paid by every applicant. Entry Application and fees must reach the address listed on the entry form by 4:00 p.m., May 4, 2018. Refer to refund policy on stldga.com.

**REGISTRATION:** All players must be ready to play at appropriate starting point and published starting time.

Entry fee includes Hors D' Oeuvres following play.

**PRACTICE PRIVILEGES:** Practice privileges at Fox Run Golf Club are extended by appointment only by calling the golf shop at 636-938-4653.

### CADDIES; AUTOMOTIVE TRANSPORTATION:

A player may provide his own caddie at any time during the Championship, provided the caddie is not a participant in the Championship, or a player may carry his own clubs. Players may use automotive transportation. Entry fee includes cart fees during play.

GOLF BALLS; EQUIPMENT: Only brands of golf balls on the most current USGA Conforming Ball List may be used. The Optional Condition, as set forth in Appendix I of USGA Rules of Golf, which places a limitation on golf balls used during a round (One-Ball Rule), is NOT in effect. All clubs utilized during the Championship must be conforming under USGA Rules. (See Appendix II, USGA Rules of Golf)

**RULES OF GOLF:** Play will be governed by the United States Golf Association Rules of Golf.
